The extended abstract submission deadline is Wednesday, April 15, 2015, 23:55:00 CET. *Author Notifications will be sent in May, 2015.*

Please adhere to the following abstract submission guidelines:

- The prerequisite for handing in an abstract is that it represents **original work not previously published** and not being considered for publication elsewhere.
- Abstracts can be submitted for **poster** presentation
- Abstracts must be submitted in English language only
- The abstract should be no longer than **2000 characters** (without space characters)
- The abstract should state the purpose, methods and results of the study
- Please ensure complete listing and correct order of all (co-)authors, correct formatting and grammar. Accepted abstracts will be printed and published as they have been submitted. Changes are not possible anymore after the deadline
- Only abstracts from registered delegates who paid the registration fees in full will be published in the abstract book (ELSEVIER "Toxicology Letters")
- The main author should present the abstract on-site
